**AGREEMENT No. _____
ON COOPERATION**

Dnipro, Ukraine

Ukrainian State University of Science and Technologies (Dnipro, Ukraine), hereinafter referred to as "USUST", represented by the rector SUKHYI Kostiantyn Mykhailovich, on the one hand, and Tokat Gaziosmanpaşa University (Tokat, Turkey), hereinafter referred to as "TOGU", in the person of the rector Fatih YILMAZ, on the other hand, jointly referred to as the "Parties" based on the Law of Ukraine "On Higher Education", concluded this agreement regarding the following:

1 Subject of the Agreement

The subject of this agreement is the implementation of cooperation on a free basis in the following areas:

1.1 exchange of scientific and technical information and experience in using new pedagogical and computer technologies for teaching, holding scientific conferences, educational and practical and scientific and methodological seminars;

1.2 internships and advanced training of scientific-pedagogical and pedagogical workers.

2 Obligations of the parties

USUST:

2.1 provides TOGU with information about scientific conferences and meetings, educational and practical, and scientific and methodological seminars;

2.2 provides TOGU with information on areas and specialties of advanced training;

2.3 provides the opportunity to exchange experience, and undergo advanced training (internship) for employees in basic areas and relevant departments under separate agreements.

TOGU:

2.4 provides the State Higher Educational Institution of the USUST with information about holding scientific conferences and meetings, educational and practical and scientific and methodological seminars;

2.5 provides an opportunity for exchange of experience, and internships for scientific-pedagogical and pedagogical workers at the relevant departments.

3 Responsibility of the parties

3.1 The “Parties” are responsible for the untimeliness and unreliability of the information provided.

3.2 The “Parties” undertake not to disclose confidential news that has become known in the process of joint activities.

4 Term of validity and procedure for terminating the contract

4.1 This Agreement shall enter into force upon its signing by the “Parties” and remain in force for 5 years.

4.2 Termination of the Agreement or change of its terms may be carried out by agreement of the parties that concluded this Agreement.

5 Other conditions

5.1 This Agreement is concluded in 2 copies, each with equal legal force.
